On October 10, 2014, the Centers for Medicare & Medicaid Services (CMS) announced the Medicare Parts A and B premium and coinsurance rates for 2015. The standard Part B premium of \$104.90 will remain unchanged.

Based on the analysis conducted by both Aon Hewitt and Cheiron, it remains in the County's best interest to continue subsidizing the Part B premium for LACERA members. A recommendation from the LA County Chief Executive Office to continue the reimbursement program for the 2015 calendar year was approved by the Board of Supervisors at their meeting on December 9, 2014.
