- B. Annual Claims Audit Reports

Cathy Weis of Aon presented the results of the annual Anthem Blue Cross medical and Cigna dental plan audits.

Anthem's financial accuracy improved compared to the 2013 audit. However, there was a significant decrease in performance for overall accuracy and payment accuracy, and also a decrease in claim handling time performance results. A known system issue with Medicare Sequestration, discovered in the 2013 audit, was the cause for almost all errors identified, as well as impacting claim turnaround time. Anthem put a system enhancement in place in January, 2014, however, it was not programmed correctly. Anthem implemented a fix to the system on June 15, 2014, specifically for LACERA. With the Medicare Sequestration issue corrected, the 2015 audit results are expected to meet or exceed Aon Hewitt performance objectives.

Anthem is currently working on an impact analysis and action plan to address incorrect benefit payments.

The Cigna Dental Plan met Aon Hewitt's excellent level of performance, with financial and payment accuracy at 100%. There were no financial errors in the audit samples, with only three non-financial errors. Turnaround time within 14 calendar days did not improve over the previous audit, however, Cigna is still meeting Aon Hewitt's performance objective.
